Bid must be valid for a period of 120 days from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format as mentioned in above which shall be valid for 30 days beyond the validity period of the bid. However, the last date for bid submission and opening shall be the next working day after the last date of bid purchasing.
